## TRACT "X":

That portion of the Northeast ¼ of the Southeast ¼ of Section 29, Township 34 North, Range 4 East, W.M., described as follows:

Beginning at a point on the West line of said Northeast ¼ of the Southeast ¼, 800 feet South of the intersection of the said West line with the South line of the Little Mountain Road; thence East parallel with said South line of said road, a distance of 240 feet:

thence South at right angles, 200 feet;

thence West at right angles 240 feet to the West line of said Northeast ¼ of the Southeast ¼; thence North along said West line 200 feet to the point of beginning;

EXCEPT that portion thereof being more particularly described as follows:

Beginning at the Northeast corner of the above-described parcel, being a point on the West right-of-way margin of South 19<sup>th</sup> Street, as shown on "AEMMER ADDITION TO MOUNT VERNON" as per plat recorded in Volume 7 of Plats, page 92, records of Skagit County, Washington;

thence North 89°41'00" West, parallel with the centerline of Blackburn Road (called Little Mountain Road in previous description) along the North line of the above-described parcel for a distance of 121.00 feet; thence South 0°26'20" West parallel with said South 19<sup>th</sup> Street (called South in the previous description) for a distance of 115.00 feet;

thence South 89°41'00" East for a distance of 102.96 feet;
