As of May 14, 2008, there is an outstanding balance of \$480.00 due and owing in connection with the following property at Skagit Highlands:



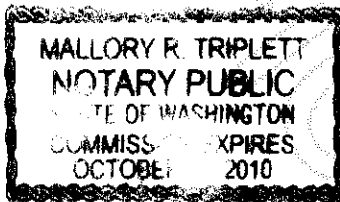
