As of June 23, 2008, there is an outstanding balance of \$640.00 due and owing in connection with the following property at Skagit Highlands:



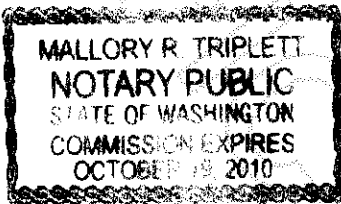
