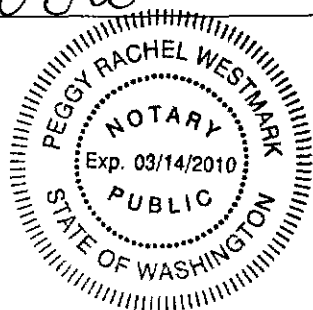

DESCRIPTION:

PARCEL "A":

That portion of the Southeast $\frac{1}{4}$ of the Southeast $\frac{1}{4}$ of Section 23, Township 34 North, Range 4 East, W.M., described as follows:

Beginning at a point where the Westerly line of the right of way of the Northern Pacific Railway Company intersects the Section line between Sections 23 and 26 in said Township and Range; thence West along said Section line to the point of intersection with the Easterly line of the State Highway, as now established; thence Northwesterly along said Easterly line to a point where said Easterly line intersects a line parallel with and distant 330 feet North of the Section line between said Sections 23 and 26; thence East on a line parallel with and distant 330 feet North from said Section line to a point where said parallel line intersects said Westerly line of the right of way of the Northern Pacific Railway Company; thence Southeasterly along said Westerly line to the point of beginning; being that tract of land lying between the right of way of said Northern Pacific Railway Company and the State Highway West thereof and between the South line of said Section 23 and a line parallel thereto and distant 330 feet North therefrom.

Situate in the County of Skagit, State of Washington.

PARCEL "B":

That portion of the Westerly $\frac{1}{2}$ of that certain 100 foot wide strip conveyed to the Seattle, Lake Shore and Eastern Railway Company by Deed dated December 29, 1890 and recorded January 7, 1891, in Volume 13 of Deeds, page 620, records of Skagit County, Washington, which lies South of a line drawn parallel with and 330 feet North of the South line of the Southeast $\frac{1}{4}$ of the Southeast $\frac{1}{4}$ of Section 23, Township 34 North, Range 4 East, W.M.

Situate in the County of Skagit, State of Washington.

PARCEL "C":

A triangular piece of ground in Section 26, Township 34 North, Range 4 East, W.M., described as follows:

Beginning at the Northeast corner of said Section 26; thence South along the Section line between Sections 25 and 26 to a point of intersection of said Section line with the East line of the County road as now established; thence following said East line of said County road in a general Northwesterly direction to a point where the East line of said County road intersects the section line between Sections 23 and 26; thence East along said Section line to the point of beginning, containing about one acre, more or less.
