EXHIBIT "A"

LEGAL DESCRIPTION

That portion of the Northeast ¼ of the Northwest ¼ of Section 27, Township 34 North, Range 2 East, W.M., described as follows:

Beginning at the intersection of the East line of the Snee-Oosh County Road and the South line of said Northeast ¼ of the Northwest ¼, said point being the Northwest corner of Lot 2, "REPLAT OF ASSESSOR'S PLAT OF ASHLAND ADDITION, DIVISION NO. 1," as per plat recorded in Volume 13 of Plats, page 1, records of Skagit County, Washington, being a Replat of that certain plat recorded in Volume 10 of Plats, page 44, records of Skagit County, Washington;

thence East along the South line of the subdivision, a distance of 400 feet to the Northeast corner of said Lot 2;

thence North parallel to the East line of said County Road, a distance of 100 feet to the Southeast corner of Lot 3, "REPLAT OF ASSESSOR'S PLAT OF ASHLAND ADDITION, DIVISION NO. 1," as per plat recorded in Volume 13 of Plats, page 1, records of Skagit County, Washington;

thence West parallel to the South line of said subdivision, a distance of 400 feet to the East line of the County Road, said point also being the Southwest corner of said Lot 3;

thence South along the East line of said road, 100 feet to the point of beginning.
