## SUBORDINATION AGREEMENT

NOTICE: THIS SUBORDINATION AGREEMENT RESULTS IN YOUR SECURITY INTEREST IN THE PROPERTY BECOMING SUBJECT TO AND OF LOWER PRIORITY THAN THE LIEN OF SOME OTHER OF LATER SECURITY INSTRUMENT. GUARDIAN NORTHWEST TITLE CO.

- The undersigned subordinator and owner agrees as follows:

  1. Peoples Bank referred to herein as "subordinator", is the owner and holder of a mortgage dated May 7, 2008, which is recorded under auditor's file No.200805080053, records of Skagit County.
- 2. Peoples Bank referred to herein as "lender", is the owner and holder of a mortgage dated August 25, 2008, executed by Dan R Mitzel and Patricia R Burklund (which is recorded under auditor's file No. 2000 2400 15, records of Skagit County) (which is to be recorded concurrently herewith).
- 3. Dan R. Mitzel and Patricia R Burklund referred to herein as "owner", is the owner of all real property described in the mortgage identified above in Paragraph 2.
