Beginning at the Northwest corner of the South ½ of the Southwest ¼ of the Northwest ¼ of Section 29, Township 34 North, Range 4 East, W.M.;

thence South 89°46'00" East (called South 89°40'00" East on previous description) along the North line of said South ½ of the Southwest ¼ of the Northwest ¼ for a distance of 134.49 feet, more or less, to a point on the West line of that certain city street known as Railroad Avenue, as conveyed to the City of Mount Vernon by Deed dated July 30, 1955 and recorded August 18, 1955, under Auditor's File No. 522706.

thence South 3°06'00" West along said West line of Railroad Avenue for a distance of 142.64 feet to the true point of beginning of said line description;

thence South 3°06'00" West along the West line of said Railroad Avenue, a distance of 13.23 feet to the true point of beginning of this property description;
