- I am the surviving spouse of DICK ARLEN DAVIS ("Decedent"), who died August 21, 2008 at 1. Anacortes, Washington. At that time, Decedent and I were residents of Anacortes, Skagit County, Washington.
- On January 30, 2003, Decedent and I, while married, executed an agreement entitled 2. "Community Property Agreement" ("the Agreement"), which is attached hereto. The Agreement provides that all property owned at the time of the Agreement or thereafter acquired by either or both spouses is community property, and that such property vests in fee simple in the survivor immediately upon the death of either spouse. We were legally competent at the time of the Agreement and have executed no subsequent Wills or other instruments that would have the effect of abrogating or nullifying the Agreement.
