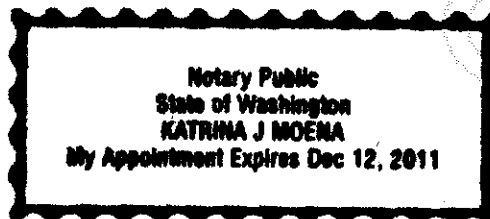

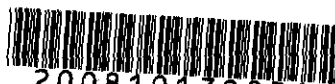

COUNTY RECORDS.

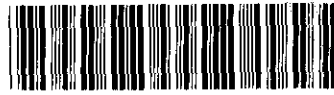
