6	3.1 Plaintiff's lien shall be a first and prior lien upon the following-described real property, superior to any right, title, claim, lien or interest on the part of the Defendants or persons claiming by, through or under the Defendants:		
7	Lots 49 and 50, Block E, Division I, "Cape Horn on the Skagit, Skagit County,		
8 9	Washington, as per the plat recorded in Volume 8 of Plats, pages 92-97 inclusive, records of Skagit County, Washington. (P63080; P63081)		
10	3.2 The lien described herein shall be foreclosed and the said real property shall be sold in one or more parcels in accordance with and in the manner provided by law.		
11	3.3 Plaintiff shall be permitted to be a purchaser at the sale; that the net proceeds of said sale		
12	be applied first toward the payment of the costs of said sale and then towards the payment of Plaintiff's judgment.		
13	3.4 Plaintiff shall have and retain a deficiency judgment against Defendants, in the event that		
14 15	the bid(s) at the sale(s) are less than the sum of Plaintiff's entire judgments, plus the costs of sale.
