FIRST AMENDMENT TO EASEMENT

THIS FIRST AMENDMENT TO EASEMENT (the "First Amendment") is entered into this the day of November, 2008 ("Effective Date"), by and between Race Bannon Ventures, LLC, a Washington limited liability company ("Grantor") and Bob and Irene Embrey, a married couple, Michael and Lauren Farley, a married couple, Steve and Tonia Schmokel, a married couple, Cheryl and Ray Wilson, a married couple, and Guemes Orchard, L.L.C., a Washington limited liability company ("Lot Owners") some, or all of whom, together comprise the Guemes Seaview Water System ("Water System"). The Lot Owners and the Water System are collectively referred to in this First Amendment as the "Grantee".

RECITALS

- A. WHEREAS, The Bank of California, N.A. as Trustee ("Original Grantor"), and Thompson Land and Engineering, Inc. ("Original Grantee") entered into that certain Easement Agreement dated September 23, 1991, and recorded in Skagit County under document number 9207100011 ("Original Easement");
- B. WHEREAS, Under the Original Easement, Original Grantor granted Original Grantee the right to install and maintain a well and waterline on a portion of that certain property legally described on attached Exhibit A incorporated herein ("Burdened Property");
- C. WHEREAS, The property benefitted under the Original Easement is now comprised of 5 lots owned by the individual Lot Owners and is the same property benefitted under this First Amendment as legally described on attached Exhibit B incorporated herein ("Benefitted Property");
- D. WHEREAS, As of the date of this First Amendment, Grantor herein owns the Burdened Property;
- E. WHEREAS, The Water System operates and maintains the well and water line located on the Burdened Property;
- F. WHEREAS, Grantor is pursuing a Conservation and Reserve Development ("CaRD") on the Burdened Property;
- G. WHEREAS, The Water System and the Lot Owners support Grantor's CaRD and agree to refrain from taking any action that could negatively affect Grantor's CaRD; and
- H. WHEREAS, Grantor and Grantee desire to amend the Original Easement as set forth herein; and
- NOW THEREFORE, For good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, Grantor and Grantee agree that the Original Easement is hereby restated in its entirety and amended only as specifically set forth below:
- 1. <u>Deletion from Original Easement</u>. Paragraph 5 of the Original Easement is hereby deleted in its entirety.

- 2. Amendment to Paragraph 4 of Original Easement. Paragraph 4 of the Original Easement is hereby deleted in its entirety and replaced by the following Paragraph 4:
 - 4. The Original Easement including this First Amendment shall be for a term of five (5) years and shall be automatically renewed for additional five-year terms so long as Grantee is not in default under the terms thereof beyond any applicable cure period or until the Original Easement including this First Amendment terminates pursuant to its terms.
- 3. <u>Amendment to Paragraph 7 of Original Easement</u>. Paragraph 7 of the Original Easement is hereby deleted in its entirety and replaced by the following paragraph 7:
 - Grantee agrees, to indemnify Grantor, excluding only claims resulting 7. from the sole negligence or intentional wrongful act of Grantor, and to hold Grantor harmless from and against any and all known or unknown claims, demands, costs, expenses and liabilities in any way arising out of or relating to the Original Easement and/or this First Amendment and the exercise of the rights granted to Grantee under the Original Easement and this First Amendment, including without limitation any damage to the well and/or the well water, or inability to use the well and/or the water from the well for any purpose whatsoever, and including reasonable attorneys' fees incurred by Grantor in defense of such claims. Grantor and Grantee agree to notify the other party of any such claim against either party or in any way related to the rights granted under the Original Easement and/or this First Amendment. Grantee agrees to obtain and keep in force throughout the entire term of the Original Easement and this First Amendment an extended form liability insurance policy with limits of liability not less than One Million Dollars (\$1,000,000) per occurrence with respect to personal injury and Five Hundred Thousand Dollars (\$500,000) with respect to property damage, to name Grantor as an insured on such policy and to provide Grantor with a certificate of such insurance including an endorsement providing that Grantor shall receive not less than thirty (30) days notice of any cancellation or termination of such policy.
