THIS MATTER having come on ex parte, upon application by Plaintiff for judgment; an 2 Order of Default having been entered against defendant; now, therefore, judgment is hereby 3 4 entered against defendant Peter Criscuolo, and in favor of plaintiff, as follows: 5 Judgment shall be entered in favor of plaintiff and against defendant in the principal 2.1 amount of \$4,176.40. 6 Plaintiff shall further be awarded its taxable costs in the amount of \$120.00, and a 2.2 7 reasonable attorney's fee of \$525. 8 2.3 Interest on the judgment, costs, and attorney's fees shall bear interest at 12% per annum. 9 10 III. DECREE OF FORECLOSURE 3.1 Plaintiff's lien shall be a first and prior lien upon the following-described real property, 11 superior to any right, title, claim, lien or interest on the part of the Defendants or persons 12 claiming by, through or under the Defendants: 13 Lot 18, "Cascade River Park Div. No. 1", as per plat recorded in Volume 8 of Plats, pages 55-59 inclusive, records of Skagit County, Washington. 14 (P63565) 15 3.2 The lien described herein shall be foreclosed and the said real property shall be sold in one or more parcels in accordance with and in the manner provided by law. 16 Plaintiff shall be permitted to be a purchaser at the sale; that the net proceeds of said sale 3.3 be applied first toward the payment of the costs of said sale and then towards the payment 17 of Plaintiff's judgment. 18 3.4 Plaintiff shall have and retain a deficiency judgment against Defendant, in the event that 19 the bid(s) at the sale(s) are less than the sum of Plaintiff's entire judgment, plus the costs of sale. 20 3.5 After the sale of said property, all right, title, claim, lien or interest of the Defendants, and of every person claiming by, through or under the Defendants, in or to said property, including the right of possession thereof from and after said sale, be forever barred and 21 foreclosed and that the purchaser(s) at said sale be entitled to immediate possession of the 22 premises as allowed by law, subject only to such statutory rights of redemption as the Defendants may have by law. 23 24 3.6 In the event Plaintiff is the purchaser at said sale and possession of said premises are not immediately surrendered to the Plaintiff, a writ of assistance shall be issued directing the 25 Sheriff of Skagit County, Washington, to deliver possession of said premises to the Plaintiff. 26 27 DONE IN CHAMBERS on 28 29
