

Orin Edson, Grantor, and Pacific Marine Management, Inc., Grantee, by that document dated December 8, 1986, and recorded December 18, 1986, under Auditor's File No. 8612180026, records of Skagit County, Washington, said point being the TRUE POINT OF BEGINNING; thence continuing South 89°47'55" East along the South line of the above-described tract, a distance of 115.00 feet to the Southeast corner thereof; thence North 2°12'25" East along the East line and its Northerly extension thereof, a distance of 355.85 feet; thence North 89°47'55" West a distance of 53.55 feet to the beginning point of a curve to the left, having a central angle of 87°59'40" and a radius of 74.00 feet; thence Westerly and Southerly; following said curve to the left an arc distance of 113.65 feet to its end; thence South 2°12'25" West a distance of 284.39 feet to a point which bears North 89°47'55" West from the TRUE POINT OF BEGINNING; thence South 89°47'55" East a distance of 10.01 feet to the TRUE POINT OF BEGINNING.
