## MEMORANDUM OF TERMINATION OF LEASE AGREEMENT

This Memorandum of Termination of Lease Agreement, effective as of 11:59 P.M. on December 5, 2008, is between the Port of Skagit County, a Washington municipal corporation ("Lessor"), and Concorde Group Aviation, Inc., a Washington corporation ("Lessee").

This document is recorded for the purposes of providing notice that that certain Restated Land Lease Agreement recorded May 8, 2008 under Skagit County Auditor's File number 200805080081 (the "Lease"), by which Lessor agreed to lease to Lessee that certain real property owned by Lessor, commonly referred to as Lot 53, and more particularly described as:

A portion of Amended Lot 53, of Amended Skagit Regional Airport Binding Site Plan, Phase 1, AF/# 200303040030, (formerly Skagit Regional Airport Binding Site Plan Phase 1, AF/# 8608250002) comprised of the following components;

The "Building Lot" located north and east of the Building Restriction Line on Exhibit A, consisting of 2.73 acres or 118,767 square feet, except the area depicted as "Proposed Road"; and

The "Access Area south and west of the Building Restriction Line (which consists of 109,215 square feet.
