

Lots 12 to 16, inclusive, in vacated Block 19, "Plat of the Townsite of Gibralter, Skagit Co., Washington, U.S.A.", as per plat recorded in Volume 1 of Plats, pages 19 and 20, records of Skagit County, Washington.
