

Lot 3, Skagit County Short Plat No. 31-90, approved February 6, 1991 and recorded February 8, 1991 under Skagit County Auditor's File No. 9102080001, being a portion of Tracts 60 and 61, Anaco Beach, as per plat recorded in Volume 5 of Plats, page 4, also being a portion of the Northeast 1/4 of Section 34, Township 35 North, Range I East, W.M.

TOGETHER WITH that portion of Lot 2, Skagit County Short Plat No. 31-90 described as follows:

BEGINNING at the Southeast corner of said Lot 2, Short Plat No. 31-90;
