RIGHT OF FIRST REFUSAL

For value received, PHILIP G. BURTON, a single person (Grantor) hereby grants to MARK LINNEMANN, a married person as to his separate estate (Grantee) a right of first refusal to purchase the property described above on the following terms:

- 1. <u>The Property.</u> The property that is the subject of this Right of First Refusal is located on Solstice Lane, Guemes Island, Washington, described in the attached Exhibit A.
- 2. Notice of Sale. If Grantor contemplates a specific sale of sale of said property or any portion thereof, Grantor shall notify Grantee thereof, describing in detail the terms of the contemplated sale. The furnishing to Grantee of a copy of the proposed contract of sale will constitute sufficient notice.
- 3. <u>Exercise of Right.</u> Grantee shall have fifteen (15) days after the date of the Notice of Sale within which to elect to purchase under the terms of said contemplated sale. Such election shall be made by written notice to Grantor and Grantee shall tender

the earnest money down payment or price proposed in said contemplated sale.

Thereafter, the parties shall execute such contracts and other instruments of conveyance as are necessary to consummate said sale on the terms specified in the Notice of Sale. If Grantee fails to exercise this right to purchase as hereinabove provided, Grantor shall be free to sell under the terms stated or referred to in the Notice of Sale. If Grantee fails to so elect to purchase and the terms of the contemplated sale are materially changed, Grantee shall again be given notice as hereinabove provided and shall be given the same time within which to make an election to purchase on the changed terms. If Grantee fails to so exercise this right to purchase and Grantor does not consummate said contemplated sale, Grantee shall not be deemed to have relinquished the rights herein granted in the event of a future contemplated sale.

4. <u>Notice.</u> All notices required herein shall be in writing and mailed to the party to whom directed at the addresses hereinafter set forth or personally delivered to such party. Notice shall be deemed given when deposited in the U.S. Mail, postage prepaid, or if personally delivered, when received by a party.

- 6. <u>Non-Assignability.</u> Grantee's rights under this Right of First Refusal are personal to him and may not be assigned to another party without Grantor's written consent, which may withheld without cause.
