The above-described property is valued at less than one-half of the value of our former community estate, and as the Personal Representative of the Mary Ann Funk Estate, I elect to treat the entire value of said property as part of that estate. I intend to distribute the remainder of the estate in such fashion as will result in one-half of our former community estate being treated as my separate property and one-half passing through Decedent's Will.
- (2) Pursuant to RCW 11.86.021 and Internal Revenue Code Section 2518, I hereby disclaim on my individual behalf any and all right, title and interest in the above described property. Although I understand that the Will provides that this property will pass to the MARY ANN FUNK TESTATMENTARY TRUST, I am in no way directing this result, nor making a gift of property to said trust. Any actions on my part to carry out the conveyance of this property

Funk and Mary Ann Funk, husband and wife, and the Mary Ann Funk Testamentary Trust.
