

**EXHIBIT "A"**

**LEGAL DESCRIPTION**

Lot 3 as delineated on Short Plat No. 91-104 as approved on October 6, 1994 and recorded on October 12, 1994 under Auditor's File No. 9410120004, TOGETHER WITH that portion of Lot 4 of said Short Plat described as follows:

Beginning at a point on the North line of said Lot 4, which lies 497.93 feet from the intersection of said North line with the East line of Logsdon Lane; thence North  $63^{\circ}08'51''$  East, a distance of 100.29 feet; thence North  $52^{\circ}23'09''$  East, a distance of 75.00 feet; thence North  $10^{\circ}38'08''$  East, a distance of 28.12 feet to the North line of said Lot 4; thence South  $52^{\circ}23'09''$  West along said North line, a distance of 194.51 feet to the point of beginning.

EXCEPT that portion of Lot 3 of said Short Plat described as follows:

Beginning at a point on the Southeasterly line of said Lot 3, which lies 692.44 feet from the intersection of said Southeasterly line with the East line of Logsdon Lane; thence North  $10^{\circ}38'08''$  East, a distance of 57.47 feet; thence North  $64^{\circ}07'51''$  East, a distance of 188.00 feet to the Southeasterly line of said Lot 3; thence South  $52^{\circ}23'09''$  West along said Southeasterly line, a distance of 226.94 feet to the point of beginning.

AND EXCEPT Short Plat No. 99-0017 as approved on March 2, 2001 and recorded on March 12, 2001 under Auditor's File No. 200103120137 and EXCEPT Mobile Home.

TOGETHER WITH an easement for ingress, egress and utilities as recorded on December 16, 1999 under Auditor's File No. 199912160091.
