STIPULATION FOR ENTRY OF A DECREE AND JUDGMENT OF APPROPRIATION AND ADVERSE POSSESSION

COME NOW the parties, Plaintiffs Walter J. Petersen and Frances L. Petersen, as

Trustees of the Petersen Family Trust, (hereinafter "Petersen") and Defendants Frank Morris Anne &

Hansen and Barbara Ann E. Hansen, as Trustees for the Hansen Family Trust, (hereinafter

"Hansen") and hereby stipulate as follows:

In accordance with the Complaint filed in Skagit County Superior Court in

February 2009, Cause Number 09-2-00474-1, in the above-entitled action, the Plaintiffs

Petersen request entry of a decree of adverse possession of the driveway adjoining their

residential property on Fidalgo Island, Skagit County, Anacortes, Washington, more particularly described in the map attached hereto as Exhibit A, and the legal description of the disputed property attached hereto as Exhibit B.

- 2. The Plaintiffs Petersen, are the owners of two parcels improved with a single-family residence with a street address of 11517 Coronado Dr., Anacortes, Skagit County, Washington 98221. The legal description of the single-family residential property improved with a residence is described in the petition as Parcel A, attached hereto as Exhibit C.
- 3. The Defendants Hansen are owners of an adjoining parcel situated in Skagit County, Washington, particularly described in Exhibit D, which is attached hereto and made a part of this Stipulation hereof.
- 4. The Plaintiffs Petersen and the Defendants Hansen have agreed to stipulate that the disputed property described in Exhibits A and B, which consists of the Petersen's asphalt driveway and the adjoining landscaping, planting and garden and sprinkler system to the north of the driveway have been utilized as access since 1996 when the Plaintiffs Petersen acquired the property.
- 5. The parties, the Plaintiffs Petersen and Defendants Hansen, hereby stipulate that the Petersens have at all times, since 1996, used and utilized the disputed area previously described, consisting of approximately 5,573 square feet, as their own property, and have acquired said property by adverse possession by their open, notorious and continuous use of said property.




