**APPOINTMENT OF SUBSTITUTE TRUSTEE
(Second Lien)**

This Deed of Appointment of Substitute Trustee, made and entered into this 2nd
day of September, 2009, by and between BOEING EMPLOYEES' CREDIT UNION,

Beneficiary, part of the first part, and Scott J. Rhodes and Martha E. Rhodes, Husband and Wife
(to be indexed as the Grantor), and Chicago Title Insurance Co., as SUBSTITUTE TRUSTEE,
herein "Substitute Trustee".

WHEREAS, by Deed of Trust dated October, 12, 2006 and recorded November, 16, 2006
as Audit Number 200611160098, was conveyed in trust to Regional Trustee Services
Corporation, set forth therein to secure payment of an indebtedness in the original amount of
\$110,000.00, payable to BOEING EMPLOYEES' CREDIT UNION; and

WHEREAS, the aforesaid Deed of Trust contains a provision whereby the holder of the
aforesaid promissory note, at its discretion, may remove the Trustees named under the said Deed
of Trust and appoint a Substitute Trustee (s), with all the title, power and duties conferred upon
the Trustees in the Deed of Trust by applicable law; and

WHEREAS, the undersigned is the present owner and holder of the promissory note
secured by the aforesaid Deed of Trust and desires to remove the aforesaid Trustee and any and
all Substitute Trustee (s) heretofore appointed under the said deed of trust and to substitute the
said Substitute Trustee for the aforesaid Trustees.

NOW, THEREFORE, THIS APPOINTMENT OF SUBSTITUTE TRUSTEE.

WITNESSETH:

that for and in consideration of the premises and pursuant to the terms and provisions of the aforesaid deed of trust, the undersigned does hereby remove the aforesaid Trustees and any and all Substitute Trustee (s) heretofore appointed under said deed of trust and further does hereby designate and appoint the said Chicago Title Insurance Co., as Substitute Trustee under the said Deed of Trust, with all rights, powers and duties as Trustee as provided in the said Deed of Trust, which said rights, power and duties may be exercised.
