That portion of the South 1/2 of the Southeast 1/4 of the Northeast 1/4 of Section 18, Township 34 North, Range 4 East, W.M., described as follows:

Beginning at a point on the West line of the right-of-way of former State Highway, now Riverside Drive, 20 feet North of the South line of said South 1/2 of the Southeast 1/4 of the Northeast 1/4; thence North along said right-of-way line 100 feet; thence West 120 feet; thence South 100 feet to a point 20 feet North of the South line of said South 1/2 of the Southeast 1/4 of the Northeast 1/4; thence East 120 feet to the point of beginning.
