Final Order to Vacate

The Board, having on the 15th day of September, 2009, ordered the vacation of a portion of said County right-of-way known as Gunderson Road upon payment by the principal petitioner of all remaining costs and expenses incurred in the proceedings, with said costs and expenses amounting to the sum of \$3,773.48 to be paid to the Treasurer's Office of Skagit County.

It is ordered by the Board of Skagit County Commissioners to vacate a portion of County right-of-way known as Gunderson Road, requested by Mr. Lance Fisher, described as follows:

BEGINNING AT THE SOUTHEAST CORNER OF SECTION 24, TOWNSHIP 34 NORTH, RANGE 4 EAST, W.M., thence N 00°15'50" E, along the east section line of said section 24, a distance of 524.81'; thence N 89°44'10" W a distance of 61.84' to the **TRUE POINT OF BEGINNING**;

thence 20' on each side of a centerline described as follows; thence a curve turning to the left with an arc length of 79.67', with a radius of 440.70', with a chord bearing of N 04°00'59" W, with a chord length of 79.57', thence a curve turning to the left with an arc length of 52.89', a radius of 440.70', a chord bearing of N 12°37'55" W, and a chord length of 52.85', to a PC 86+85.599; thence N 16°04'28" W a distance of 60.90' to a PT 86+24.699; thence along a curve turning to the left with an arc length of 587.52', a radius of 716.20', a chord bearing of N 39°34'19" W, and a chord length of 571.19', thence a curve turning to the left with an arc length of 104.91', with a radius of 716.20', with a chord bearing of N 67°16'09" W, with a chord length of 104.81',

EXCEPT that portion thereof lying north of the southern edge of the right-of-way deeded as Gunderson Road; and that portion thereof lying east of the western edge of the right-of-way deeded as Goldie Lane,

Containing 28,372 ft²
Situate in the County of Skagit, State of Washington
Less any Franchises or Easements of record

An easement in gross is hereby reserved within the vacated right-of-way for all existing and future utilities, including extensions and improvements thereto, and recognition of any franchises of record.
