ACCESS ROAD AGREEMENT

For Ten Dollars (\$10.00) and other valuable consideration, Robert R. Bever, located at 5705 State Route 9, Sedro Woolley, WA 98284 ("Grantor") does grant, sell and convey to NORTHWEST PIPELINE CORPORATION, located at 295 Chipeta Way, Salt Lake City, Utah 84158 ("Grantee"), a perpetual right-of-way approximately 46.51 feet in length and 59.61 feet in width on which to construct, maintain and use a roadway for the construction, operation and maintenance of Grantee's natural gas pipeline facilities ("access road") which access road is situated in Skagit County, State of Washington, more particularly described below:

A portion of Lot 2, Short Plat No. 26-79, recorded August 17, 1979, in Book 3 of Short Plats, page 163, under Skagit County Auditor's File No. 7908170006, being within the Northeast Quarter of the Southwest Quarter of Section 31, Township 36 North, Range 5 East, W.M.

The survey description of the access road is designated on Exhibit "A" attached hereto and made a part of this agreement.

It is understood and agreed that the use of the access rights granted do not and will not extend generally for the use of the public, but are limited to and for the use of the Grantee, its successors, assigns, agents, employees or contractors.

Grantee will possess the above-described rights and such rights will be binding upon Grantor, its heirs, legal representatives and successors in title.

Grantor agrees to indemnify and hold Grantee harmless for damages of any kind which arise due to the negligent acts or willful misconduct of the Grantor, its successors, assigns, permittee, agents or contractors.
