

A continuing restraining order is entered as follows:

The wife is restrained and enjoined from disturbing the peace of the other party. The wife is restrained and enjoined from going onto the grounds of or entering the

> home, work place or school of the other party, or the day care or school of the following named children: a) Lauren Taylor Gere at Mt. Eric Elementary, Montessori and any and all schools she attends after Mt. Eric; b) Ashton Giovanni Gere at Whitney Elementary, his summer program or any and all other schools he attends after Whitney.

The wife is restrained and enjoined from knowingly coming within or knowingly remaining within 100 yards of the home, work place or school of the other party, or the day care or school of these children: Lauren Taylor Gere and Ashton Giovanni Gere as well as Philip William Gere, Jr. at his residence and his workplace at Gere-a-Deli.

Elizabeth Gere is restrained and enjoined from molesting, assaulting, harassing, or stalking Philip William Gere, Jr. (The following firearm restrictions apply if this box is checked: Effective immediately and continuing as long as this continuing restraining order is in effect, the restrained person

may not possess a firearm or ammunition. 18 U.S.C. § 922(g)(8). A violation of this federal firearms law carries a maximum possible penalty of 10 years in prison and a \$250,000 fine. An exception exists for law enforcement officers and military personnel when carrying department/government-issue firearms. 18 U.S.C. § 925(a)(1).)

OTHER: Before Wife can remove 1993 Honda Accord, 4-door sedan, license plate # WA 027VX5 from Laurie Gere's property in Anacortes, wife must remove husband from title. Further, no more dismantling of the vehicle may occur until the vehicle is removed from Ms. Gere's property. EXCEPTION: Child exchanges are not a violation of the restraining order so long as the exchanges do not occur at husband's residence or place of business or at the children's schools.

The restrained party or attorney did not appear in court; service of this order is required. The protected party must arrange for service of this order on the restrained party. File the original Return of Service with the clerk and provide a copy to the law enforcement agency listed above.

Expiration

This restraining order expires on: September 1, 2010. This restraining order supersedes all previous temporary restraining orders in this cause

The clerk of the court shall forward a copy of this order, on or before the next judicial day, to: Snobomish County Sheriff's Department or Arlington Police Department law enforcement agency where Petitioner resides which shall enter this order into any computer-based criminal intelligence system available in this state used by law enforcement agencies to list outstanding warrants.

Full Faith and Credit

Pursuant to 18 U.S.C. § 2265, a court in any of the 50 states, the District of Columbia, Puerto Rico, any United States territory, and any tribal land within the United States shall accord full faith and credit to the order.
