THIS MATTER having come on ex parte, upon application by Plaintiff for judgment; an Order of Default having been entered against Defendants; now, therefore, judgment is hereby entered against defendants, and in favor of plaintiff, as follows:

- Judgment shall be entered in favor of Plaintiff and against Defendants in the principal amount of \$1,184.10, plus prejudgment interest of \$78.58, for a total judgment of 2.1 \$1,262.68.
- Plaintiff shall further be awarded its taxable costs in the amount of \$401.00, and a 2.2 reasonable attorney's fee of \$1,500.
