3 1. That Plaintiff, Alaska USA Federal Credit Union, is awarded judgment against the
4 Defendant Kenneth K. Clark for principal of \$11,709.59, together with prejudgment interest of
5 \$1,258.55 as of 12/4/2009, costs of \$320.44 and attorney's fees of \$1,000.00, for a total judgment
6 of \$14,288.58. Principal, costs and attorney's fees shall bear interest at the rate of 9.25 percent
7 per annum from the date of judgment.

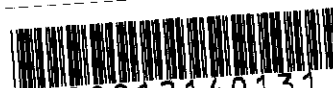
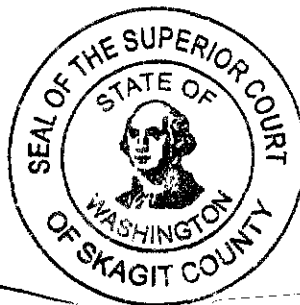
