<u>EASEMENT</u>

- 2.1 <u>Grant of Perpetual Easement</u>. Grantor hereby grants to Grantee an easement, subject to all preexisting easements, as described herein of the type described herein for the purposes described herein.
- 2.2 <u>Purpose</u>. The purpose of this nonexclusive easement is for the construction, maintenance and operation of a Storm Water System over, across and under the Burdened Property. The storm water from the Benefited Property is conveyed along the easement area to the storm water detention and treatment facility located on Pond Tract F (as delineated and set forth on the face of the Sierra Pacific Binding Site Plan number PK 08-0315, recorded under AF number 200911160068, the "Binding Site Plan"), currently exits the west side of the detention and treatment facility and ultimately discharges into the public drainage facility known as "Indian Slough" (the "Storm Water System"). 




