the undersigned subordinator and owner agree as follows:

- 1. <u>Peoples Bank, A Washington Corporation</u> referred to herein as "subordinator", is the owner and holder of a <u>Deed of Trust</u> dated <u>February 12, 2003</u> which was recorded on <u>February 13, 2003</u> under auditors file No <u>200302130071</u> records of <u>Skagit County</u>.
- 2. Peoples Bank, it successors and assigns referred to herein as "lender", is the owner and holder of a Deed of Trust dated JANUARY 5, 2010 , executed by Michael Duffy and Linda E. Duffy, husband and wife, which is recorded under auditor's file No. 201001110053 records of Skagit County (which is to be recorded concurrently herewith).
