RECITALS:

- This conveyance is made pursuant to the powers, including the power of sale, conferred upon said Trustee by that certain Deed of Trust between BARBARA MORRISON AN UNMARRIED WOMAN AND JAMES FRESHOUR, AN UNMARRIED MAN EACH AS THEIR SEPARATE ESTATE, as Grantor, to LAND TITLE COMPANY OF SKAGIT, as Trustee, and MORTGAGE ELECTRONIC REGISTRATION SYSTEMS, INC., AS NOMINEE FOR HOMECOMINGS FINANCIAL, LLC (F/K/A HOMECOMINGS FINANCIAL NETWORK, INC.), as Beneficiary, dated 11/30/2007, recorded 12/12/2007, as Instrument No. 200712120091, in Book/Reel, Page/Frame , records of Skagit County, Washington.

The Trustee, in its aforesaid "Notice of Trustee's Sale," fixed the place of sale as , The main entrance to the Skagit County Courthouse, 3rd and Kincaid Street, Mount Vernon, Washington, a public place, on 12/18/2009 at 10:00 AM, and in accordance with law caused copies of the statutory "Notice of Trustee's Sale" to be transmitted by mail to all persons entitled thereto and either posted or served prior to 90 days before the sale; further, the Trustee caused a copy of said "Notice of Trustee's Sale" to be published once between the thirty-fifth and twenty-eighth day before the date of sale, and once between the fourteenth and seventh day before the date of sale in a legal newspaper in each county in which the property or any part thereof is situated: and further, included in this Notice; which was transmitted to or served upon the Grantor or his successor in interest, a "Notice of Foreclosure" in substantially the statutory form.
