

person or persons legally entitled thereto, the Estate now held by Trustee under said Deed of Trust.



N.A. as successor Trustee, have caused this instrument to be executed, each in its respective interest on 01/14/2010.

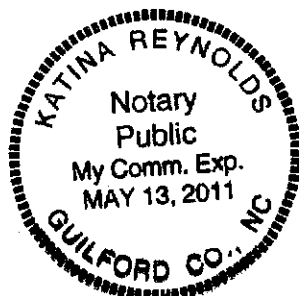
