13 April 22, 2008 and an Order Confirming Arbitration Award herein; now, therefore,

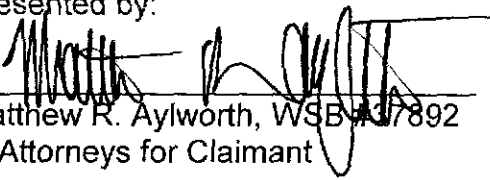
14 IT IS HEREBY ORDERED AND ADJUDGED that the Claimant shall have and recover
