Purpose: Additional language added to 13.1.1 regarding homeowner's responsibility

regarding claims occurring within a homeowner's residence.

THIS AMENDMENT is made this 4th day of Qune, 2010, by the Cedar Springs Homeowners Association.

WHEREAS, a Declaration of Covenants, Conditions, Restrictions, Easements, and Reservations for Cedar Springs PUD located in Anacortes, Washington, was recorded at Auditor's File No. 20011080126 among the land records of Skagit County, Washington, and said Declaration has previously been amended by Amended Declaration recorded at Auditor's File No. 200610240160;

WHEREAS, pursuant to Article 22 of the Declaration, the Declaration may be amended by consent of seventy-five percent (75%) of the members of the Association;

WHEREAS, by a duly held affirmative vote of the Association on January 30, 2010, more than seventy-five percent (76%) of the members of the Association voted to clarify the homeowner's responsibility regarding claims occurring within a homeowner's residence;

NOW, THEREFORE, pursuant to Article 22 of the Declaration, the Association hereby amended the Declaration as followings:

- 1. Article 13.1,1 is hereby amended to read as follows:
- 13.1.1 Fire insurance, with an extended coverage endorsement (including vandalism, malicious mischief, sprinkler leakage, debris removal, cost of demolition, windstorm and water damage), in an amount as near as practicable to the full insurable replacement value (without deduction for depreciation) of the Common and Limited Common Areas and the Buildings with the Board named as insured as trustee for the benefit of the Owners and Mortgagees as their interest may appear, or such other fire and casualty insurance as the Board shall determine to give substantially equal or greater protection insuring the Owners and their Mortgages as their interest may appear. Said policy or policies shall provide for separate protection for each Unit to the full insurable replacement value thereof (limited as above provided), and a separate loss payable endorsement, in favor of the Mortgagee(s) of each Lot, if any, and further, a separate loss payable clause in favor of the Mortgagee of the Planned Unit Development, if any. All insurance shall be obtained from an insurance carrier rated Triple A (and rated as in Class XI or better financial condition) by Best's Insurance Reports or equivalent rating service, and licensed to do business in the State of Washington. For any claim within a homeowner's residence, the homeowner shall be responsible for a portion of the Homeowners Association insurance policy. Should damage occur in multiple units, the individual homeowner shall be responsible for a portion of the deductible which reflects the percentage of that unit's claim.
