All that portion of Government Lot 1, Section 10, and the Southwest ¼ of the Northwest ¼ of Section 11, Township 34 North, Range 1 East, W.M., described as follows:

Beginning at a point on the line between Sections 10 and 11, said point lying North 00°09'19" East a distance of 332.56 feet from the quarter corner common thereto;

thence South 88°08' East a distance of 719.52 feet to an intersection with the West line of the County road known as Lateral Highway No. 4;

thence North 32°30' East along said West line for a distance of 119.74 feet;
