PARCEL "A":

That portion of the Northeast $\frac{1}{4}$ of the Northeast $\frac{1}{4}$ of Section 23, Township 35 North, Range 4 East, W.M., described as follows:

Beginning at a point on the Southerly line of the right of way of the Fairhaven and Southern Railroad through Section 23, Township 35 North, Range 4 East W.M., which is 854 feet Northwesterly from the intersection of said South line with the East line of said section;
thence running Southwesterly 490 feet along a line, which if projected would intersect the Southwest corner of the Northeast $\frac{1}{4}$ of the Northeast $\frac{1}{4}$ of said Section 23;
thence Northwesterly 100 feet on a line parallel with the Southerly line of the right of the Fairhaven & Southern Railroad;
thence in a Northeasterly direction 490 feet to a point on the Southerly line of the right of way of the Fairhaven & Southern Railroad which is 100 feet Northwest of the point of beginning;
thence Southeasterly along the said Southerly line of the right of way of the Fairhaven and Southern Railway to the point of beginning, EXCEPT that portion, if any, lying Southeasterly of the Northwesterly line of those premises conveyed to Henry Welker, by deed dated December 24, 1903, filed March 9, 1904, as File No. 47628 and recorded in Volume 57 of Deeds, page 204.

PARCEL "B":

That portion of the Northeast $\frac{1}{4}$ of the Northeast $\frac{1}{4}$ of Section 23, Township 35 North, Range 4 East W.M., described as follows:

Beginning at a point on the Southerly line of the right of way of the Fairhaven and Southern Railroad right of way which is 854 feet Northwesterly from the intersection of said Southerly line with the East line of said Section;
thence Southwest in a straight line, (which if projected would intersect the Southwest corner of the Northeast $\frac{1}{4}$ of the Northeast $\frac{1}{4}$ of said Section 23), a distance of 490 feet to the true point of beginning;
thence Northwesterly 100 feet on a line parallel with the Southerly line of the right of way of said Fairhaven and Southern Railroad;
thence Southwest on a line parallel with the aforesaid line measuring 490 feet Northeast and Southwest, to a point on the West line of the Northeast $\frac{1}{4}$ of the Northeast $\frac{1}{4}$ of said Section 23;
thence South to the Southwest corner of said Northeast $\frac{1}{4}$ of the Northeast $\frac{1}{4}$ of said Section 23;
thence Northeast to the said true point of beginning; EXCEPT that portion if any lying Southeasterly of the Northwesterly line of those premises conveyed to Henry Welker by deed dated December 24, 1903, filed March 9, 1904, as File No. 47628 and recorded in Volume 57 of Deeds, page 204.
