THE GRANTOR, REGIONAL TRUSTEE SERVICES CORPORATION, as present Trustee under that Deed of Trust, as hereinafter particularly described, in consideration of the premises and payment, recited below, hereby grants and conveys without warranty, to: Deutsche Bank National Trust Company, as Trustee under Pooling and Servicing Agreement dated as of November 1, 2006 Securitized Asset-Backed Receivables LLC Trust 2006-WM3 Mortgage Pass-Through Certificates, Series 2006-WM3, GRANTEE, that real property, situated in the County of SKAGIT, State of WASHINGTON, described as follows:

AS NOMINEE FOR WMC MORTGAGE CORP. ITS SUCCESSORS AND ASSIGNS, as Beneficiary.

Said Deed of Trust was executed to secure, together with other undertakings, the payment of a promissory note in the sum of \$237,600.00, with interest thereon, according to the terms thereof, in favor of MORTGAGE ELECTRONIC REGISTRATION SYSTEMS, INC. AS NOMINEE FOR WMC MORTGAGE CORP. ITS SUCCESSORS AND ASSIGNS and to secure any other sums of money which might become due and payable under the terms of said Deed of Trust.

Deutsche Bank National Trust Company, as Trustee under Pooling and Servicing Agreement dated as of November 1, 2006 Securitized Asset-Backed Receivables LLC Trust 2006-WM3 Mortgage Pass-Through Certificates, Series 2006-WM3, being then the holder of the indebtedness secured by said Deed of Trust, delivered to said Trustee written request directing said Trustee to sell the described property in accordance with the law and the terms of said Deed of Trust.

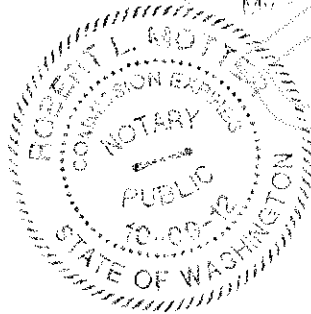
