# FIRST AMENDMENT TO DECLARATION FOR QUANTUM BUSINESS PARK CONDOMINIUM

PURPOSE: TO CHANGE CONDOMINIUM ATTRIBUTES PRIOR TO SALE OF UNITS

THIS AMENDMENT is made this 2nd day of August , 2010, by QUANTUM BUSINESS PARK, L.L.C., ("Declarant").

#### WITNESSETH THAT:

WHEREAS, the Declarant caused a certain Condominium Declaration (the "Declaration") establishing Quantum Business Park Condominium ("the Condominium") to be recorded at Auditor's File No. 200908070064 among the land records of Skagit County, Washington, along with a Survey Map and Plans, which were contemporaneously recorded at Auditor's File No. 200908070065;

WHEREAS, pursuant to Section 17.6 of the Declaration, the Declarant may unilaterally amend the Condominium Instruments from time to time prior to the sale of any Units in the project to third parties.

WHEREAS, the Declarant wishes to include a Development to "create additional Units within the real property included in the Condominium" to the list of Development Rights described in Section 3.3.1 of the Declaration.

NOW, THEREFORE, pursuant to and in compliance with Section 17.6 of the Declaration, the Declarant hereby amends the Declaration as follows:

## 3.3.1 Description of Reserved Development Rights.

Pursuant to RCW 64.34.216(1)(j), the Declarant has reserved Development rights which are personal to the Declarant and may be unilaterally exercised, or not exercised, at the sole discretion of the Declarant. These include the rights to: create additional Units, Common Elements, or Limited Common Elements within the real property included in the Condominium, as described more particularly in Sections 4.1, 5.1, and/or 6.1 of the Declaration; subdivide Units or convert Units into Common Elements; create additional Common Element loading dock/ramp and signage facilities; reallocate Limited Common Elements with respect to Units that have not been conveyed by the Declarant; and to assign portions of the Common Elements as Limited Common Elements pursuant to RCW 64.34.216(1)(I).

### 4.1 Number and Location of Units.

#### 4.1.1 Initial Units.

The Condominium presently contains seventeen (17) commercial Units which are depicted on the Survey Map and Plans. The location of existing commercial Units within the buildings and the dimensions of those Units are shown on the Condominium Survey Map and Plans. Exhibit B to the Declaration contains a list of all existing Units, their identifying numbers, size, the Allocated Interests appurtenant to each Unit, and other information required by the Condominium Act.

### 4.1.2 Units Created Through Exercise of Development Rights.

The Declarant reserves the right to add a maximum of three (3) additional Units, and/or to expand Units 16, 20 or 22 into surrounding Common Elements, pursuant to Development Rights reserved in Section 3.3.1 of this Amendment to Declaration.

EXCEPT as modified by this Amendment, all of the terms and provisions of the Condominium Instruments are hereby expressly ratified and confirmed and shall remain in full force and effect.
