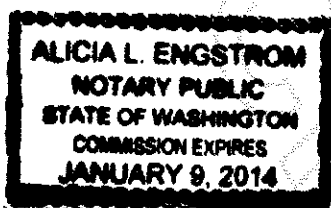

Parcel A

The South Half of the Northeast Quarter, the Southeast Quarter of the Northwest Quarter, the East Half of the Southwest Quarter, and Government Lots 5, 6, and 7, Section 10, Township 34 North, Range 2 East, W.M.; EXCEPT Indian Reservation Road, Skagit County Road No. 204.

Parcel B

All that portion of the following described property, lying within Section 10, Township 34 North, Range 2 East, W.M.;
