LOAN EXTENSION OF THE PROMISSORY NOTE AND DEED OF TRUST

ONE ORIGINAL LOAN PROMISSORY NOTE, MODIFICATION EXTENSION AGREEMENTS MUST BE EXECUTED BY THE BORROWER: ONE ORIGINAL IS TO BE FILED WITH THE NOTE AND ONE ORIGINAL IS TO BE RECORDED IN THE LAND RECORDS WHERE THE SECURITY INSTRUMENT IS RECORDED

This Balloon Loan Modification ("Modification"), entered into effective as of 2Dday of between David Starkovich, Unmarried ("Borrower"), and U.S. Bank N.A. ("Lender"), and given to Mortgage Electronic Registrations Systems, Inc. ("MERS") (solely as nominee for Lender, and Lender's successors and assigns), as beneficiary, MERS in organized and existing under the laws of Delaware, amends and supplements (1) the Mortgage, Deed of Trust or Deed to Secure Debt (the "Security Instrument"), dated June 27, 2007, securing the original principal sum of U.S. \$238,500.00, recorded on June 29, 2007, Document Number 200706290178 and in Skagit County Records in the State of Washington. (2) the Balloon Note bearing the same date as, and secured by the Security Instrument (the "Note) which has been assigned MERS Registration No. 1000212 7884574571 5 and MERS Registration Date June 8, 2007 which covers the real and personal property described in the Security Instrument and defined in the Security Instrument as the "Property," located at: 6965 HOBSON RD BOW WA 98232, the real property described being set forth as follows:

LOT 1 OF SKAGIT COUNTY SHORT PLAT NO. 96-097, RECORDED MARCH 8. 2007, UNDER AUDITOR'S FILE NO. 200703080151, RECORDS OF SKAGIT C OUNTY, WASHINGTON; BEING A PORTION OF THE SOUTHEAST QUARTER OF T HE SOUTHEAST QUARTER OF SECTION 1, TOWNSHIP 35 NORTH, RANGE 3 EA ST OF THE WILLAMETTE MERIDIAN. SITUATE IN SKAGIT COUNTY, WASHINGTON.

In consideration of the mutual promises and agreements exchanged, Lender and Borrower agree as follows: (notwithstanding anything contrary contained in the Note or Security Instrument)

This is a Mortgage Amendment as defined in M.S 287, 01 Subd 2, and as such does not secure a new or increased amount of debt.

- As of August 1, 2010, the amount payable under the Note and Security Instrument (the "Unpaid Principal Balance") is U.S. \$221,732.04.
- The Borrower promises to pay the Unpaid Principal Balance, plus interest, to the order of the Lender. Interest will be charged on the Unpaid Principal Balance at a yearly rate of 4.00%, beginning August 1. 2010. The Borrower promises to make monthly payments of principal and interest of U.S. \$1,120.21, beginning on the 1st day of August 2010, and continuing thereafter on the same day of each succeeding month until principal and interest are paid-in-full. If on July 1, 2013 ("Modified Maturity Date"), the Borrower still owes amounts under the Note and the Security Instrument, as amended by this Promissory Note, Modification Extension, the Borrower will pay these amounts in full on the Modified Maturity Date. At this time of Maturity Date, full principal balance is due in full.

The Borrower will make such payments at 4801 Frederica Street, Owensboro, Kentucky 42301 or at such other place the Lender may require.

- The Borrower will comply with all other covenants, agreements, and requirements of the Note and Security Instruments, including without limitation, the Borrower's covenants and agreements to make all payments of taxes, insurance premiums, assessments, escrow items, impounds, and all other payments that the Borrower is obligated to make under the Security Instrument; however, all terms and provisions of the Loan Modification Agreement are forever canceled, null and void, as of the maturity date of the Note.
- 4. Nothing in this Modification shall be understood or construed to be a satisfaction or release in whole or in part of the Note and Security Instrument. Except as otherwise specifically provided in this Modification, the Note and Security Instrument will remain unchanged and in full effect, and the Borrower and Lender will be bound by, and comply with, all terms and provisions thereof, as amended by this Modification.
