default, or repay the debt as is given to the grantor in order to avoid the trustee's sale.


3. You are advised that you will have no right to redeem the property after the trustee's sale.

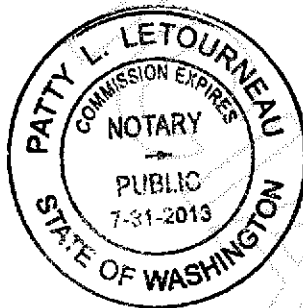
