Failure to bring such a lawsuit may result in a waiver of any proper grounds for invalidating the Trustee's Sale.

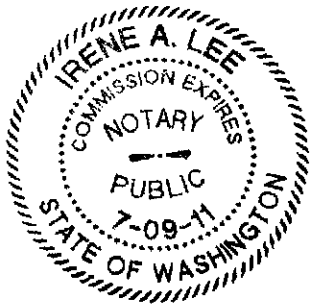
