

- 1. Peoples Bank, A Washington Corporation referred to herein as "subordinator", is the owner and holder of a Deed of Trust dated May 18, 2010 which was recorded on May 19, 2010 under auditors file No 201005190011 records of Skagit County
- 2. Peoples Bank referred to herein as "lender", is the owner and holder of a Deed of Trust dated 10-4-1010, executed by Gary Rowell and Terry Rowell, husband and wife, which is recorded under auditor's file No. 20\0\000001003records of Skagit County (which is to be recorded concurrently
- 3. Gary Rowell and Terry Rowell, husband and wife referred to herein as "owner", is the owner of all real property described in the mortgage identified above in paragraph 2.
- 4.
