## AMENDMENT TO LEASE AGREEMENT

## RECITALS

WHEREAS, the Port of Skagit County, a Washington municipal corporation ("Lessor") and Alyeska Ocean Aviation, LLC, a limited liability corporation, ("Lessee") entered into a land lease agreement recorded under Skagit County AF # 200807160133, dated October 1, 2007, for the property described as 11694 Higgins Airport Way, Burlington, WA, Lot 5 of Binding Site Plan PL06-0913 recorded under Auditor's File No. 200706180136, consisting of approximately 6,593 square feet of land; and

WHEREAS, this lease was restated on July 1, 2008 reflecting the address change to 11730 Higgins Airport Way, and

WHEREAS, Alyeska Ocean, Inc. was the sole owner of Alyeska Ocean Aviation, LLC; and

WHEREAS, Alyeska Ocean Aviation, LLC was dissolved as of July 8, 2009; and

WHEREAS, Lessor has undertaken an effort to bring all leases at Skagit Regional Airport under consistent provisions for the handling of storm water and landscape maintenance responsibilities; and

WHEREAS, the Lessor and the Lessee have agreed that their existing lease agreement be modified to reflect Alyeska Ocean, Inc. as the Lessee and to add uniform provisions with respect to the handling of storm water and landscape maintenance responsibilities, NOW THEREFORE,

## **AGREEMENT**

IT IS HEREBY MUTUALLY AGREED, by and between the Lessor and Lessee that:

- A. The Lease Agreement is hereby amended as follows:
- This amendment shall cause the name of the Lessee to be changed from "Alyeska Ocean Aviation, LLC," a Washington limited liability corporation, to "Alyeska Ocean, Inc.," a Washington corporation.
- All references to "Alyeska Ocean Aviation, LLC" are hereby deleted and replaced with "Alyeska Ocean, Inc."

All other terms and conditions of the LAND LEASE AGREEMENT above referenced except as herein amended are confirmed, ratified and confirmed in all respects and are to remain in full force and effect. This agreement shall bind and inure to the benefit of the successors and assigns of the Lessor and Lessee.
