


MASTER FORM DEED OF TRUST

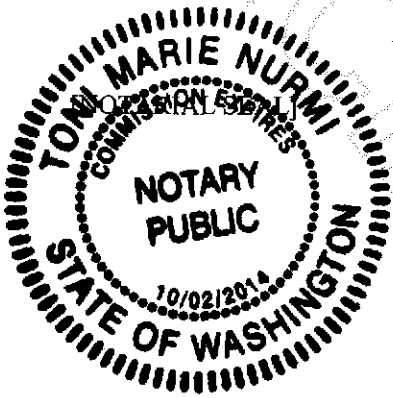
