The sale will be made without warranty, express or implied regarding title, possession, or encumbrances on 03/11/2011. The default(s) referred to in paragraph III, together with any subsequent payments, late charges, advances costs and fees thereafter due, must be cured by 02/28/2011 (11 days before the sale date), to cause a discontinuance of the sale. 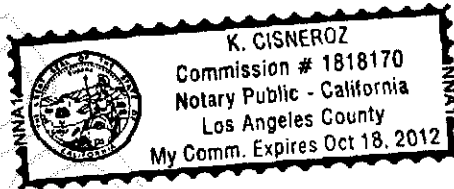
