EASEMENT AGREEMENT

THIS EASEMENT AGREEMENT (this "Agreement") is made this \(\frac{\psi^{\psi}}{\psi}\) day of \(\frac{\psi^{\psi}}{\psi}\), 2010, by and between Travis and Laurel Lohman, husband and wife ("Lohman"), and Randy and Theresa Bartelt, husband and wife ("Bartelt").

RECITALS

- A. Lohman is the owner of certain real property located in Section 24, Township 34 North, Range 4 East of W.M., Skagit County, Washington as more specifically depicted on the attached Exhibit A (the "Burdened Property").
- B. Bartelt is the owner of certain real property located in Section 24, Township 34 North, Range 4 East of W.M.; Skagit County, Washington as more specifically depicted on the attached Exhibit B (the "Benefited Property").
- C. Subject to the terms and conditions contained in this Agreement, Lohman desires to grant an easement over a portion of the Burdened Property to Bartelt (the "Easement").
 - D. Capitalized terms shall have the meanings ascribed to them herein.

AGREEMENT

NOW, THEREFORE, in consideration of the mutual promises and conditions contained in this Agreement, the receipt and sufficiency of which are hereby acknowledged, the parties hereto agree as follows:

- 1. Grant of Easement. Lohman does hereby grant, bargain, sell, convey, transfer and deliver unto Bartelt a nonexclusive 60-foot "Easement" for the purpose of ingress, egress, and utilities over, under, along, across and through the "Easement Area" as defined herein, and all reasonable uses incidental thereto. The Easement Area is depicted on the map attached as Exhibit C.
- 2. <u>Purchase Price</u>. The Easement granted herein shall be for no consideration. Bartelt shall be responsible for all costs associated with the recording of the Easement Agreement in the records of Skagit County, Washington.
- 3. <u>Duration of Easement</u>. The Easement herein granted shall be perpetual in duration and is given by Lohman to Bartelt, and to its successors and assigns, forever.
- 4. <u>Cost of Construction and Maintenance</u>. Each party using the roadway shall pay its proportionate share of any maintenance costs over the Easement Area that corresponds to the relative amount of use of the roadway by such party. Lohman and Bartelt, or their successors and assigns, shall agree upon the allocation of responsibility for said costs prior to undertaking maintenance (including appropriate dust control measures). Each party using any portion of the road shall repair, or cause to be repaired, at its sole cost and expense, that damage to said road occasioned by it which is in excess of that which it would cause through normal and prudent usage of said road.
- 5. <u>Indemnity</u>. Bartelt shall indemnify and hold harmless Lohman from and against all losses, claims, damages, liabilities, costs and expenses (including reasonable attorneys' fees and expenses, whether or not a lawsuit is instituted), arising out of or resulting from any actual or alleged injury to or death of any person, or from any actual or alleged loss of or damage to property, caused by any occurrence in or on the Easement or in connection with the use of the Easement by Bartelt or its employees, agents, licensees, contractors or invitees, unless such loss, damage, liability or expense is proximately caused by Lohman or its employees, agents, licensees, contractors or invitees.

Lohman shall indemnify and hold harmless Bartelt from and against all losses, claims, damages, liabilities, costs and expenses (including reasonable attorneys' fees and expenses, whether or not a lawsuit is instituted), arising out of or resulting from any actual or alleged injury to or death of any person, or from any actual or alleged loss of or damage to property, caused by any occurrence in or on the Easement or in connection with the use of the Easement by Lohman or its employees, agents,

licensees, contractors or invitees, unless such loss, damage, liability or expense is proximately caused by Bartelt or its employees, agents, licensees, contractors or invitees.

- 6. Attorneys' Fees. If it shall be necessary for either Lohman or Bartelt to employ an attorney to enforce its rights pursuant to this Agreement because of the default of the other party, the defaulting party shall reimburse the non-defaulting party for reasonable attorneys' fees and expenses.
- 7. <u>Counterparts</u> This Agreement may be executed in any number of counterparts, and each such counterpart hereof shall be deemed to be an original instrument, but all such counterparts together shall constitute but one agreement.


