
VIII.

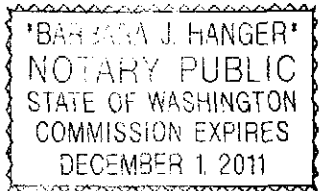



