thence East, parallel with said South line, to a line extending Northwesterly from said point of beginning to a point opposite HES 314+30 feet on said survey line and 162.90 feet Westerly therefrom;
thence Northerly to said point opposite HES 314+30;
thence Northwesterly to a point opposite HES 315+78.54 on said survey line and 259.09 feet Westerly therefrom and the end of this right of way line description.
