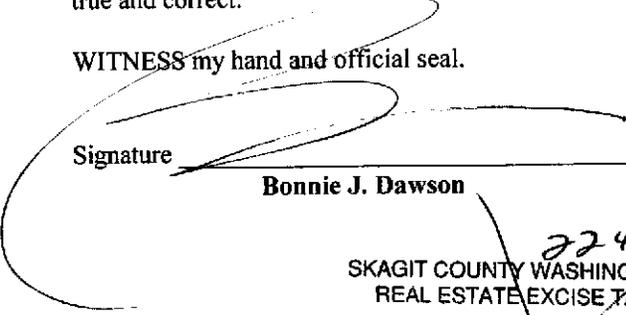

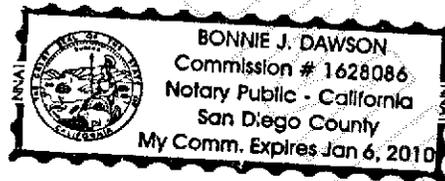

Thence Northeasterly along the centerline of State Highway 70 feet;

Thence North 45.5° West 130 feet;

Thence in a Southwesterly direction parallel to the centerline of State Highway 70 feet;
