NOTICE: THIS SUBORDINATION AGREEMENT RESULTS IN YOUR SECURITY INTEREST IN THE PROPERTY BECOMING SUBJECT TO AND OF LOWER PRIORITY THAN THE LIEN OF SOME OTHER OR LATER SECURITY INSTRUMENT.

The Undersigned subordinator and owner agree as follows:

- BOEING EMPLOYEES' CREDIT UNION referred to herein as "subordinator", is the owner and holder of a
 mortgage dated October 16, 2009 which is recorded in volume
 of Mortgages, page
 , under auditor's file no. 200910300081 records of Skagit County.
- 2. BOEING EMPLOYEES' CREDIT UNION referred to herein as "lender" is the owner and holder of the mortgage dated January 10, 2011 executed by Richard G Sleber and Kathleen M Sleber (which is recorded in volume of Mortgages, page under auditor's file no. 20101240112 records of Skagit County) (which is to be recorded concurrently herewith.)
- 3. Richard G Sieber and Kathleen M Sieber referred to herein as "owner", is the owner of all the real property described in the mortgage identified above in Paragraph 2.
- 4. In consideration of benefits to "subordinator" from "owner", receipt and sufficiency of which is hereby acknowledged, and to induce "lender" to advance funds under its mortgage and all agreements in connection therewith, the "subordinator" does hereby unconditionally subordinate the lien of his/her mortgage, identified in Paragraph 1 above to the lien of "lender's" mortgage, identified in Paragraph 2 above, and all advances or charges made or accruing thereunder, including any extension or renewal thereof.
